Buyer has paid a NON-REFUNDABLE deposit of \$ \_\_\_\_\_, The balance of the Purchase Price due is \$ \_\_\_\_\_. Balance is due upon release of the puppy or two days before shipping. The expected delivery date is \_\_\_\_\_. For private pickup, payment must be made in cash, Venmo, or Zelle. For shipped puppies, payment must be made two days prior to shipping and may be made by Venmo or Zelle. In the event that the puppy is not available due to sickness, death, or any other circumstance due to the fault of the seller, Buyer's deposit will, at Buyer's option, be either reimbursed or transferred to the next litter or a sibling from the same litter. Buyer agrees that he/she will forfeit the deposit and any rights to the puppy if: (a) Buyer fails to complete the purchase of the puppy for any reason or (b) Buyer fails to pay the balance of the Purchase Price. In either event, Seller has the right to sell the puppy to another buyer

As of date of delivery, your puppy has received the proper vaccinations, deworming, and will be examined by a licensed veterinarian. A current shot and medical report will be provided to Buyer upon delivery. Buyer must take their puppy to a veterinarian within five (5) business days to perform a "Puppy Wellness Check" and Buyer is responsible for all costs incurred. Seller does not guarantee against viral illnesses, infections, improper bites, stress-related illness, hernias, hypoglycemia, parasites (including Giardia or Coccidiosis), cancer or endocrine disorders. Health guarantee also does not include any illness due to the ingestion of foreign objects, food, chemicals or physical injury. (a) If the puppy is not taken to a licensed veterinarian within five (5) business days of taking possession, the health warranty is void. (b) Please insure that the puppy is kept in a kennel or held in the waiting room of a veterinary office, and that the exam room is properly disinfected before the appointment. (c) Do not let the puppy walk on the floor in the veterinary office and ensure the room was cleaned prior to putting your puppy on the table. I recommend bringing a clean towel or blanket with you to be safe.

Seller cannot guarantee size, temperament, or color of your puppy. This puppy is guaranteed for one year against fatal and life-altering congenital disease which does adversely affect the health of the animal and causes problems of a life-threatening or debilitating nature. If the dog dies or is diagnosed within one year of purchase date with a congenital life-threatening disease, the Seller will replace the puppy of equal value from the next litter; no cash refund will be given. Seller will not be responsible for any medical expenses incurred. Seller must be notified of the problem within 2 business days of the licensed veterinarian determination of a life-threatening or life-altering condition. There are certain disorders that may be caused by environmental factors, for example: allergies, thyroid dysfunction, demodectic mange and other autoimmune disorders that are not covered by this guarantee.

The Seller highly recommends the Buyer provide basic obedience training with their puppy within the first year of owning their dog. The Buyer agrees to postpone strenuous, forced exercise until after their puppy is over one (1) year of age to minimize joint damage as puppies develop. The Buyer agrees to contact the Seller immediately if the Buyer determines they are unable to keep their puppy for any reason. The Buyer and Seller will jointly determine how the dog will be rehomed.

The Buyer allows the Seller to use any pictures of the dog that the Buyer posts on social media for the purposes of reposting and sharing on social media in any way they choose. This guarantee is non-transferable.
